2023 PERSONAL PARTY RULES AND REGULATIONS

- 1.) To secure a date for a party, check for a free date using the HHBA web site "Events" page (hhbeach.com), then contact Linda Klusick (973-398-7869). There will be only one party allowed per weekend (Saturday or Sunday) based on first come/first served. The HHBA Personal Party Rules and Regulations form should be reviewed, signed, and returned to HHBA at P.O. Box 379 Hopatcong, NJ 07843 to confirm the reservation. A \$55.00 donation to HHBA in the form of a check or money order should accompany the form.
- 2.) No parties for personal/business financial gain such as Tupperware, Avon, etc.
- 3.) **Parties are limited to a maximum of 30 people on a weekend day (Saturday or Sunday), 50 people for a weekday event (Monday-Friday).**
- 4.) Please ensure guest parking does not obstruct emergency vehicle accessibility to the area.
- 5.) The tables in the pavilion are to be shared by both the membership at large and the reserved party. Utilizing one each if need be. Please note, your party on the premises is not considered an exclusive event and members at large will be able to access/enjoy the beach and facilities during your event.
- 6.) The grill may be used during the party. If it is used, the member holding the party is responsible for cleaning it at the conclusion of the event.
- 7.) Please clean up before you leave including sanitizing tables used. The garbage generated at your party is your responsibility. Please remove it from the premises (including the area outside the front gate) at the conclusion of the event.
- 8.) No long-term parking on driveways on HHBA premises. Drop off/pickup for supplies allowed.
- 9.) Members and guests must follow all the rules and regulations of HHBA in addition to the HHBA Personal Party Rules and Regulations listed above.
- 10.) Guests' safety, conduct, and liability are the responsibility of the host member. (PLEASE NOTE: **HHBA does not have/provide a lifeguard** on the premises).
